# Not respecting what they had to do, council appoints their friend, a proven failure, to Ward 6

The only effect this edition will have on all members of Barrie City Council, is to make them laugh.

That includes their newest and least deserving member, former Ward 7 Councillor, Steve Trotter, appointed to Ward 6, and who was thrown out of office by John Brassard in 2006, with his 1074 votes to Trotter's 899.

I'm not writing this for council. I'm writing it for the people who tell me, after soliciting their opinions during

elections, that they don't vote. They deliberately refuse to. I am giving them more reason to carry on, with that opinion. I am tempted to join them, myself.

They say that they don't vote because after people get elected and do wrong, they cannot be immediately fired; that they cannot be trusted; that they are only in it for themselves and their select, private network of friends. And, for this appointment, they would all be correct. Somebody who got fired, and showed no interest in running again for eleven years, got appointed, right back in. That is wrong.

They are called "former councillors" for a reason: They disappointed a majority of the people of their ward, and the people said, "I want you off that table." All the members of council who voted for Trotter, disobeyed the wishes of the voters. To watch Trotter come back to the council table in this way, is not a triumph for him, and not a relief for the people of Ward 6. It is anticlimactic, cynical and sad.

Council did this, because if they don't condemn themselves for doing so, the local mainstream media will not, and it takes time and money for members of the public to organize and work to punish those who did undertake this cynical act. People at large don't have that time and money to do anything. Only a very few people with an exceptional interest will try to do anything. Make that one. Me.

What happened was, Ward 6 Councillor, Michael Prowse, took over the Chief Administrative Officer (CAO) spot from Carla Ladd, who retired. That left his council seat vacant, with not enough time left in the term to warrant spending the money on a by-election, with another full election coming much less than two years away.

The members of council decided to appoint someone to Prowse's seat. As a different council did eleven years ago, with a previous appointment, they pretended that the job was open to everyone, when really, it was not.

That was their first deliberate transgression. The second, was that

they ignored several people who could have done the job, easily, and did so, relying on the elitist, bigoted, discriminatory nonsense that only a former councillor could handle the job. The clichés that were spoken to in 2006 were uttered again at the council table in 2017, before anyone had provided an application, and were spoken to yet again, on the night that the wrong choice for appointment was made.

The former councillors who applied for this were, starting with a former alderperson: Mary-Florence Bartley; Steve Trotter; Rodney Jackson; Kevin LePage and Lynn Strachan.

Thirty-two people tried for the job, with one, former councillor, Brian Jackson, having withdrawn. All thirty-one of the applicants spoke on July 10, the day a special session of council was held, to

make the appointment.

That was extraordinary, that everyone attended, and, spoke. It was then an extraordinary *insult* to those people, the twenty-six who were not among the five former members of council, that they were teased and lied to, only for the purpose of being used as window dressing and set pieces to make it look like Trotter, the former member of the Council Club<sup>TM</sup>, had beaten them, and, that they had a real chance. Council wasted the time and work of everyone who tried, who was not a former councillor. A man barely old enough to vote; a senior citizen bent over with a bad back, telling an honest story of all the jobs he held throughout his life-

none of them had a chance. Every word was wasted, speaking to a council that was not listening, and never wanted to listen and give the words, weight. Council made fools of them all, every bit as much as a carnival barker with a rigged game that cannot be won. All those people, struggling to do their best for an opportunity, trying to please and convince a council that carried on to the end, voting for former members of council. The first, Trotter, was fired from the job by the voters, and the second, Lynn Strachan, is a different story.

Terry Leigh, the former producer of the Rogers coverage for Barrie City Council, dug up old campaign footage of Strachan, and the other two, Brian Jackson and Alex Nuttall. He worked on it, to make it special. Now, it's not as special, as it was.

It is somewhat awkward to come back, in the face of that tribute, less than a term, later. If you say you are done with council, and are off to get a degree, then stick to your word, or show us that you got the degree, and are ready to go, again. Strachan's education is ongoing. She was too busy then, when she left, and is too busy now. The same, as she was not voted out of office, and was very popular in Ward 2, she would have been a better choice than any councillor that was voted out of office. And, with that said and with all due respect, she still was not a better choice than myself, as I will explain.

Council treated this job like it was any other, and their first and only moves were to place their friends to it, ignoring that the job was about the man, Michael Prowse, the person the voters selected, to have it.

Even though coming as close as possible to Prowse needed to be the goal, to please the people who voted for him, council pleased itself, and their friends, instead. It does not matter if I say I am disappointed with them all. They don't care. For this, their friends came first, and the people of Ward 6, second. This was a plum, and they kept it in the family, just like they did with another appointment, eleven years ago, using the same nonsense, to do it. If they really wanted experience, last time, a former mayor, Janice Laking, tried for it. How did they choose anyone else? They kept it in their circle of friends then, and they did it again, eleven years later. Friends come first, to these folks.

As with last time, there is not one vote or promise behind an appointed seat, and no way, technically, to fail, because the people of

Ward 6 are going to get what they are going to get, and not choose it. I say that council does not care, because contrary to their nonsense, there were plenty of people who could have done the job, and I am one of them. I also say it, because the people of Barrie were not served well by the person who got the previous appointment, another former councillor, because that person, Alison Eadie, broke her word to council, and the people of Barrie. To appoint another former councillor, right after, shows that this council has learned nothing, and endorses the former decision, not wanting to improve on it. That is sad.

Of all the others who tried this time, and even though I don't care for what she does, because she is a leftist writer, former *Barrie Advance* journalist, Laurie Watt, for years, as I did, got the same packages of reports and letters to councillors in the circulation list, that I got, when former mayor, Dave Aspden, told staff to give me the same packages the other media people received, starting in April of 2008. Again, I hate to return to Watt, but either she or I could have stepped into that job, with no learning curve or the other nonsense the councillors spoke to, as the reasons for denying competent people their chance. To the contrary, we could have done a better job than some at that table, on maybe our worst or best days, and their, respective, days.

The people voted for Prowse, and he was and is, a man in his late forties who is a frugal spender, and, like myself, a card-carrying member of the Conservative Party of Canada. Either that, or he was just hanging around for fun at the nomination for Barrie-Innisfil, while I was there, too. Yes, my Libertarian Party allows you to have other party memberships. We don't care. (continued from page A3) party. The voters were being denied their choice, with this appointment, so you must try to come as close as you can get, to that first choice, to respect what that choice, was.

Of all the applicants, I have the closest personality to Prowse, and, I had the greatest demonstrated interest in council, and that includes the former councillors, because after the spigot of money is turned off, they don't attend meetings, anymore. It was me, by a mile, if council had respected the voters. They didn't. I didn't get one vote. Prowse himself, by the way, had no vote, for this, so if you enjoy the story and agree with me, don't blame him.

The earlier appointee was former councillor, Eadie, who, at the time of being appointed to Patrick Brown's vacated Ward 3 seat, which he left to become the MP for Barrie, was working for Brown as his constituency assistant. That was wrong. And then, it got worse, when, after her short term expired, she broke her word and ran for Ward 10. She got beaten, by Alex Nuttall. Who fought that decision, the most? I did. I was the only one who did. I tried to sue the City for negligence, for mismanaging the process

and keeping it secret. That decision was made in a private session. This latest appointment was made during a public session, with applicants able to speak, and all the votes were public.

Yes, you can thank me, for that. Nobody else stepped up. I did. Steve Trotter was one of the councillors who made that bad decision to appoint Eadie in 2006. Now he has come full circle, and after being voted out of office later that year, 2006, he has been appointed back, eleven years later, by the same process, using the same false argument that only a former councillor can handle the job. Poetic, and disgusting. It is no wonder, that people choose not to vote!

Experience? When an airline pilot flies his plane into the ocean, do you give him the job back, because he has experience on the job? To be voted out of office is to be fired from the only job that requires you to get it, by being voted into it, to begin with. This council either does not understand this, or they do, and do not give a damn. My money is on the latter. Either way, it's all bad.

I reviewed all the application materials from every applicant. I noted that Dave Forfar, the City's former Deputy Fire Chief who had been fired in 2013, was applying. I noted after a search for his last name that a woman with the same last name, Stacey Forfar, was already working for the City as its Manager of Growth Planning. There is no law against that. The same, I asked Forfar to confirm or deny that his daughter already had an executive position at the City, with an email I sent to him and council. He replied and admitted it.

On reflection, performing that superior level of due diligence probably only harmed my chances. On the other hand, not doing so, and just putting my name in, with no supplementary materials, would have been used as an excuse to select a former member of council, had I complained afterward, and, if any of them bothered to explain themselves, which they would not have done, anyway. The reason

why each approach could not have worked, was that I thought too well of these people, to do the right thing. And I was way, way off in regards to how much Conservative ideology we shared. I always accepted that none of council's Conservatives or their friends could donate to my Libertarian campaigns, because of their ties to the next closest party, the Conservatives. Yet with an opportunity of this kind, an appointment, I believed that our shared ideology would be respected. Not only was it not respected, it was not even considered; it never entered any of their minds. All they thought of was their private, inner circle. I never bothered lobbying any of them, aside from one text message to one of them who is not Conservative, because all of them already know me and what I stand for, politically, and what I stand for, is in simpatico with the way Prowse acted while on council.

And although I said in this edition that technically, Watt could have done the job, too, her story on the appointment, "Watt shares wisdom after a week of lobbying and playing politics," for the *Barrie Today*

website, was short, shallow, and – like her application supplementary materials – relied on clichés. Over at the *Examiner*, Bob Bruton's story, "Beats Strachan in 5-4 vote of council," was nothing more than stenography, minus clichés. Where is the full reporting, analysis and deep commentary? It is here. Only here.

I also had the very best endorsement of anyone who applied for the job: My friend, and World War II veteran, Cliff Hall, whom I met years ago, at Barrie City Hall. We were both activists against a deal involving moving the YMCA to the Old Allandale Train Station.

Council should have been flattered that Hall took an interest in what they do, and should have given his endorsement a lot more weight. I have the skills to do the job, and I gave council a clean criminal record check. It was an even choice between myself and the others who could have done the job, and while in the second round, five voted for Trotter, four of the members of council voted for Strachan. I have nothing against her, however, I will speak against council's decision: What would those members have said, if asked by the people of Ward 6 who voted for Prowse, who they appointed?

"Strachan has a strike against her from the Integrity Commissioner, and left the election that day. She provided no proof of her ongoing education with her application, she has four children, no time to put you first, spends freely and fought Prowse tooth and nail when he successfully eliminated the corrupted personal arts grants program."

Here is what those who voted for her, could have been proud to say, if asked why they voted for me: "Roskam is just like Prowse, he doesn't want to spend your money if he doesn't have to. He has been attending council meetings personally and writing of them for a decade, he voted for Prowse while in Ward 6, has written highly of Prowse for years, fought the same arts grants as an activist, and was endorsed by a WWII hero." This was one of the original six I thought I had. Frugal spender, for the most part. Bonnie told me her husband voted for me, in the federal election, and she once came to me, and had a chat about the arts grants I was

fighting. She was the first to speak, on why she voted the way she did. With Peter missing, I knew I was lost as soon as she mentioned the most significant thing for her, which was ward residency.

She doesn't appreciate that matching the man, Michael, is the most important thing. Ward residency for an appointment, is a simpleminded aspect to give priority to. While it is folksy and attractive for an election, an appointment is an emergency, and the personality of the man elected is more significant than his address. Most of council is not even from Barrie. I am. Nobody cares. If your address is the most important thing, then being born and raised here should be more important than any ward residence, and, again, nobody cares. Then she got to "experience." If that is what matters, for a job that pretty much anyone from any walk of life could do, which is why it is open to anyone to get elected to it, why tease everyone with a job that they cannot apply for? Ironic how when Jeff asked for her comments, which was her rationale for voting as she did, and not her vote, itself, she misunderstood what he meant. Then, after she was done with her comments, she interrupted Rose, as she began, hers. Maybe Bonnie needs more experience. Or maybe she needs to move to Ward 6, before she can even make a decision on Ward 6. And what did she say, to add to her earlier comments? That if we had a larger council, she would like to appoint everyone. Great. There were certainly people who applied who would not be good for the job. Bonnie would have voted for them all. Her own words. She obviously didn't read all the supplemental materials, to have said that. To be honest, I don't really think she was serious. It was just the first of many sops that the councillors offered, as they politely dismissed, with faux drama, all people not former councillors, as too stupid to do the job.



First ballot: Lynn Strachan; Second: Lynn Strachan After Lynn pulled out of the race for Ward 2, I offered to help Rose for no charge, with the graphic design for her campaign materials. She decided against it. I didn't expect her to vote for me. That she voted for Lynn, her

former rival, is odd. She said the decision was "very tough." To vote for your former rival? Not tough. Weird. She must have been given a guarantee from Lynn or her brother, Keith, that they would not move on Ward 2 in 2018. No other explanation for it, and the decision to try to install a spender, does not serve the interests of the people who voted for Michael, a tightwad. If Lynn moves on this seat in 2018, then I am wrong. If she doesn't, this was a deal for the benefit of both parties, not the people of Ward 6. To vote for Lynn without this guarantee makes even less sense, as Lynn is in Ward 2, with the home advantage, and Rose, is not. If Lynn and her brother so much as turn in the general direction of Ward 2, it is theirs to take back. For the 2010 election, there were three candidates in Ward 2; their names and votes: Matt Dean 262; Rose Romita 1,104; Lynn M. Strachan 2,798.

In 2014, with Lynn withdrawn, Rose grew by only 152 to 1,256 to beat Steve Jones by 29 votes, with James McVeigh only 108 behind Steve. Do the math. Ward 2 is/was Lynn's for the taking in 2018, if she wanted it. And even though this vote is the most self-serving of the bunch, and makes the least sense for Ward 6, I respect Rose for paying for her entire campaign, herself. And here is another prediction: With her 2018 run to defend, Rose will have access to the same old money that supports most of the rest of council, during elections. Rose spent \$4,894.03 in 2014. In 2010, Lynn spent none of her own money and received \$7,200.00 in contributions, and spent \$7,064.64. With Lynn leaving Ward 2 alone and Rose having done her best to give her the appointment, that old money should be Rose's, now. She will need it. I expect Steve and James to be trying, again.

A politician is friendly with most everyone he knows. I feel I was the best, for the reasons stated in this edition. And, that Andrew is Conservative, and a Libertarian such as myself, is a more extreme Conservative, so I more than match his own political views. Andrew's first choice was Gary Harvey, a police officer who ran against him in Ward 7. I read his supplementary materials, as well as everyone else's.
